Nexgen Media Air Cleaner Limited Five Year Warranty

This Nexgen product is warranted by Nexgen Air Conditioning Heating and Plumbing ("Nexgen"), to the original owner to be free from defects in material and workmanship, under normal use and maintenance, within its listed capacity, for a period of five years from the date of purchase, except however, for the disposable media filter, which will have to be replaced from time to time depending upon the use. This Nexgen product must not have been moved from the site of original installa-tion. Nexgen's exclusive obligation, and the owner's sole remedy, under this warranty shall be for Nexgen to supply, without charge, a replacement for any part of the Air Cleaner which is found to be defective and is returned by the owner, together with the serial number, date of installation, and proof of purchase. Failing this, Nexgen will guarantee the unit for a period of sixty (60) months from the date of manufacture listed on the product's rating plate. Any part replaced pursuant to this warranty is warranted only for the unexpired portion of the warranty term applying to the original part.
